### Application Screening Requirements

1. **Copy of the owner's driver's license or state ID** - must be received in order to complete a credit and background check through a third-party site, Lease Runner. You will receive an e-mail request to log on to their Web site along with instructions to begin the screening criteria and make a payment of \$35. Once the report is completed, Lease Runner will provide the marina office a copy.
2. **Recent photo of the boat** - preferably a broadside view with registration number or vessel name legibly viewed.
3. **Current registration or documentation** – if you recently purchased the boat, a copy of the bill of sale is required. The registration or documentation should be provided within 30 days.
4. **Proof of insurance** (see – with amount of no less than \$500,000 worth of protection and indemnity coverage (including pollution and wreck removal) as well as Driscoll Mission Bay and the City of San Diego listed as additional insured, to read as follows:

5. **Current utility bill** (water or electric) of current residence.

### Marina Monthly Slip Rates

#### Slip Size – Price per Foot

- 25' and 30' Double Wide - \$13/foot
- 25' Single Wide - \$14/foot
- 32'-35' Single Wide - \$14/foot
- 40'-43' Single Wide - \$15/foot
- 45'-53' Single Wide - \$16/foot
- 55'-93' Single Wide & End Ties - \$25/foot
- Inner Side Ties 25' + 3' docking space (<9' beam) - \$13/foot
- Inner Side Ties max 34' + 3' docking space - \$14/foot

- Slip rates are determined by overall length of slip or vessel, whichever is greater.
- Maximum allowed overhang is 3 feet.
- **No liveboards permitted.**

#### Flat Rate Utility Fee

- 30-amp vessels per plug \$1.00/foot, water included
- 50-amp vessels per plug \$2.00/foot, water included
- **\*\*Higher usage tenants will be subject to additional fees\*\***

#### Required Deposits

- Security deposits = 1.5x monthly rent
- Key Card deposits = \$100.00 per key card
- **\*\*Deposits are subject to change based on credit/vessel condition\*\***

#### Facilities

- Individual single wide slips are provided with a dock box and shared access to water and electricity.
- Two sets of restrooms, showers and a laundry room
- Permit parking, adjacent public parking
- Storage lockers available for \$50 per month

#### Guest Rates

- Daily - \$3/foot/day plus key deposit of \$100.00, refunded once key is returned
- Weekly - \$10.50/foot/day plus key deposit of \$100.00, refunded once key is returned
- Monthly - \$30/foot/day plus key deposit of \$100.00, refunded once key is returned
- **\*\*Holidays are charged at double the rate**
