Application Screening Requirements

- 1. **\$35 Application Fee** To ensure a spot into the wait list, all applicants must pay a non refundable administrative application fee that is processed upon application completion.
- Copy of the owner's driver's license or state ID Must be received in order to complete a credit and background check through a third-party site, Lease Runner. You will receive an e-mail request to log onto their Website along with instructions to begin the screening criteria and make a \$37 payment for screening fee. Once the report is completed, Lease Runner will provide the marina office a copy.
- 3. Recent photo of the boat Preferably a broadside view with registration number or vessel name legibly viewed.
- 4. **Current registration or documentation** If you recently purchased the boat, a copy of the bill of sale is required. The registration or documentation should be provided within 30 days.
- 5. Current utility bill Water or electric of current residence.
- 6. **Proof of insurance** Current proof of insurance with \$500,000 minimum worth of protection and indemnity coverage including pollution/wreck removal.(See insurance checklist for reference pg2) As well as Driscoll Mission Bay listed as additional insured, to read as follows:

Marina Monthly Slip Rates

- 25' and 30' Single & Double Wide \$15/foot
- 32'-35' Single Wide \$16/foot
- 40'-43' Single Wide \$18/foot

Flat Rate Utility Fee

- 30-amp vessels per plug \$1.00/foot, water included
- 50-amp vessels per plug \$2.00/foot, water included

Facilities

- Individual single wide slips are provided with a dock box and shared access to water and electricity.
- Restrooms & showers.
- Permit parking, adjacent public parking
- Storage lockers available for rent: Small: \$50 Large: \$100 Per month

- 45'-53' Single Wide \$19/foot
- 50'-53' Single Wide \$20/foot
- 55'-93' Single Wide & End Ties \$30/foot

Required Deposits

- Security deposits = Based on credit
- Key Card deposits = \$100.00 per key card

Guest Rates

- Daily \$3/foot/day plus key deposit of \$100.00, refunded once key is returned
- Holidays are charged at a higher rate

Important: Slip rates are determined by overall length of slip or vessel, whichever is greater. Maximum allowed overhang is 3 feet. No commercial / chartering or subletting allowed. Higher usage tenants will be subject to additional fees. Deposits are subject to change based on credit/vessel condition

Documents Required to show Proof of Insurance

- A Certificate of Insurance showing all coverages per your Wharfage Contract.
- Copy of the Declaration Page
 - o Detailed description of all exclusions & endorsements.
 - In lieu of the copy, Driscoll will accept a line item on a Certificate of Insurance stating; copy is available upon request.
- If slip tenant is purchasing new insurance the following are required:
 - A copy of the Binder stating Driscoll Mission Bay as additional insured.

Additional Insured:

- Driscoll Mission Bay as Additional Insured on all policies as follows:
 - o Driscoll Mission Bay, 1500 Quivira Way, San Diego, CA 92109
- Language such as "Additional Interest" and others are not accepted.

Other Requirements:

• All vessels must be in seaworthy condition during their occupancy at Driscoll Mission Bay.

Notes:

- If requested, Owner shall provide a copy of the entire insurance policy or a link to the standard policy form on the insurance carrier's website.
- Owner agrees that Driscoll Mission Bay may change any insurance requirements based on a 30-day notice as written in the Wharfage Contract.
